Dear Governor Walz:

The Committee on Oversight and Government Reform is investigating reports of widespread fraud in Minnesota's social services programs. The Committee has serious concerns about how you as the Governor, and the Democrat-controlled administration, allowed millions of dollars to be stolen. The Committee also has concerns that you and your administration were fully aware of this fraud and chose not to act for fear of political retaliation. The Committee therefore requests documents and communications showing what your administration knew about this fraud and whether you took action to limit or halt the investigation into this widespread fraud.

Federal prosecutors in Minnesota have charged dozens of people with felonies for allegedly stealing over \$240 million in Federal Child Nutrition Program funds from a Minnesota-based non-profit Feeding our Future, a government program designed to feed children during the COVID-19 Pandemic.<sup>2</sup> Minnesota state agencies reimbursed the non-profit group and its partners invoices claiming to have fed thousands of children, when in reality, the meals were never provided, and the fraudsters spent taxpayer dollars on luxury cars, houses, foreign companies and real estate projects in Minnesota, Ohio, Kentucky, and abroad.<sup>3</sup> As of November 24, 2025, 78 defendants have been charged in the scheme<sup>4</sup> and over 55 have been convicted so far.<sup>5</sup>

This is not an isolated incident. Another group fraudulently billed the State of Minnesota in a housing stabilization scheme where the perpetrators claimed they were helping people at risk of being homeless, costing taxpayers over \$104 million.<sup>6</sup> A third group claimed to provide treatment for autistic children, all recruited from Minneapolis's Somali community, "falsely certifying them for autism treatment and paying their parents kickbacks for their cooperation." One provider has been charged so far in this scheme – allegedly stealing \$14 million in taxpayer funds.<sup>8</sup>

Reports show that the State of Minnesota saw red flags indicating that fraud was occurring in the Feeding our Future program but chose at best to ignore the signs or at worst, allowed fraud to occur. A June 2024 report from the Minnesota Department of Education to found that a threat of litigation and negative press from providers engaged in these fraud schemes "affected how state officials used their regulatory power." A former fraud investigator in the Minnesota Attorney General's Office said that state regulators, especially those in the Democrat-led administration, were "reluctant" to take action in response to allegations involving the Somali community. Reporting has also alleged that funds fraudulently obtained through the Minnesota Department of Human Services (DHS) by Minnesota's Somali community are being remitted overseas through "hawalas" to recipients in Somalia to fund the Al-Qaeda-linked Islamic terrorist group Al-Shabaab. Additional allegations from whistleblowers within DHS state that Child Care Assistance Program funds were being remitted overseas since 2014, with funds being directed to the Islamic State of Iraq and Syria (ISIS). Hese whistleblowers also allege that DHS is deleting data to cover up this rampant fraud, his while simultaneously refusing to release records on Medicaid fraud to local media. This woeful oversight of remittances is concerning, given that since 2014, under the leadership of then-Congressman and now Attorney General

Keith Ellison, oversight of remittance payments has been the purview of the state. <sup>17</sup> Ellison highlighted that this law would help the Minnesota Somali community, and recent reporting has brought to light that Ellison was caught on tape pledging to help Feeding Our Future fraudsters in a conversation that also included discussion of campaign donations from Somali community leaders to secure your donor base and, only days later, Ellison and his son accepted contributions to their campaigns from the individuals in this meeting. <sup>18</sup>

Based on these reports, the Committee is concerned that you were negligent in handling taxpayer dollars that were ultimately stolen and had systems in place that allowed the funds to be funneled to terrorist networks responsible for killing Americans. Whistleblowers have indicated that DHS employees are destroying evidence. <sup>19</sup> The Committee expects that you will take all steps to preserve evidence during this investigation.

To assist the Committee's oversight of this matter, we request the following information, covering the time period January 1, 2019 to the present unless otherwise indicated, as soon as possible but no later than December 17, 2025:

- All documents and communications between or including the State of Minnesota
  Department of Human Services and the Office of Governor Tim Walz and Lieutenant
  Governor Peggy Flanagan concerning the Feeding Our Future program including but not
  limited to Safari Restaurant, Empire Cuisine and Market LLC, S & S Catering Inc.,
  Haji's Kitchen LLC, Community Enhancement Services Inc., and Brava Restaurant &
  Café LLC;
- 2. All documents and communications between or including the State of Minnesota Department of Human Services and the Office of Governor Tim Walz and Lieutenant Governor Peggy Flanagan concerning Minnesota's Housing Stability Services Program including but not limited to Brilliant Minds Services LLC, Faladcare Inc., Leo Human Services LLC, and Liberty Plus LLC;
- 3. All documents and communications between or including the State of Minnesota Department of Human Services and the Office of Governor Tim Walz and Lieutenant Governor Peggy Flanagan concerning the EIDBI Autism Program including but not limited to Smart Therapy LLC and Asha Farhan Hassan;
- 4. All documents, records, and communications from the Minnesota Department of Commerce from the period of January 1, 2014 to the present related to any complaints and/or occurrences of remittance payments to Somalia sourced from fraudulent activity,
